## Terms of Access

You agree not use the data and/or information contained in BankCheck Data in connection with a prospectus or other offering document with respect to securities or assets of any type, or create a product which (a) competes with Lacuna Client Scope Limited’s Licensor or any of its licensors or affiliates or (b) provides the same or substantially similar functionality, content or features to the Product, and that the data and/or information is not made the subject of any payment or provided in return for any other commercial advantage and is not exploited in circumstances where it generates a revenue for you and any other person who accesses this material through you.
